5. Petitions / Correspondence

5.1 Request for a resolution to support a community event

Mayor Desjardins explains that there is no budget identified for these types of events, however, Members of Council may choose to make a contribution from their office budget.

7. Comment/Question Period

Mrs. Laviolette explains that she is still questioning why the City is insisting that the property owner of 855 Belvedere Street has to comply with the current building code as the structure in question has been in existence for some time.

Further to questions, Mr. Dave Darch explains that there was not building permit issued and the structure does not comply with the building code and is not in compliance with the zoning by-law. Mr. Darch also explains that there is a safety issue and the structure will have to be brought to standard.
