# 9.2 Supply of Dust Suppressant

# 9.5 Additional funds for Laurier-Laporte Intersection project

Further to questions, Mr. Dave Darch explains that the contract was initially awarded to install the traffic control signals. However, the scope of work changed and the sub-contractor that was retained by Partham did not estimate the cost of the additional work. Mr. Dave Darch confirms that measures will be put in place to prevent these types of situations to happen again.

#### **RECOMMENDATION COW2017-48**

WHEREAS the original contract awarded to Partham Engineering for the Laurier-Laporte intersection improvements was for an amount of \$186,419.35, excluding HST, under By-law No. 2016-53; and

WHEREAS an additional amount of \$50,000 was approved by Council in order to perform additional road and sidewalk work on all four (4) corners of the intersection under By-law No. 2016-124; and

**WHEREAS** several work items were omitted in the subcontractor's quote for the additional road and sidewalk works;

**THAT** Committee of the Whole recommends that Council approves an increase of \$14,500 to the contract with Partham Engineering Inc. to be funded from the Roads Reserve Fund.

# 9.8 Additional funds for Phase II of the Laurier Sanitary Project

Further to questions, Mr. Dave Darch confirms that he will provide the details of the invoice to members of Council via email.

#### **RECOMMENDATION COW2017-51**

WHEREAS a contract was awarded to Ottawa Greenbelt Construction Company Ltd for the Laurier street phase II sanitary sewer project for an amount of \$749,700, excluding HST; and

**WHEREAS** the award included a contingency allocation of \$61,297.40, being 6.1% of the project value; and

**WHEREAS** once construction started, an existing 300mm diameter watermain was found to be in conflict with the new 600mm diameter sanitary sewer and had to be relocated in order for the project to proceed; and

WHEREAS the cost of the corrective of work is \$207,095.52, excluding HST;

**THAT** Committee of the Whole recommends that Council approves an increase of \$190,000 to the Ottawa Greenbelt Construction Company Ltd contract, therefore increasing the upset limit amount for the contract from \$749,700 to \$939,700, excluding HST, to be funded from the Sewer Reserve Fund.

#### 9.9 Supply of Granular Material

RECOMMENDATION COW2017-52 Moved by Krysta Simard Seconded by Charles Berlinguette **THAT** the Committee of the Whole recommends that Council approves a by-Law to authorize the Mayor and the City Clerk to sign an agreement with Colacem Canada Inc. and with Cornwall Gravel Company Limited for the supply of granular material for a period of three (3) years, as per the unit prices detailed in Annex A of this Report No. INF2017-007; and

**THAT** the Committee of the Whole further recommends that staff be authorized to extend this agreement for an additional two (2) one-year year term, at the City's discretion; and

**THAT** in keeping with the bid prices provided in Annex "A", the projected costs for 2017, 2018 & 2019 will be \$295,250, \$301,425 and \$307,600, excluding HST respectively.
